### Urgent Action: US war resisters facing possible deportation

An alarming number of US Iraq War resisters in Canada (5 so far) have recently been notified that decisions are imminent in their cases; one has already received a deportation date. Others awaiting their decisions are expecting it to include a removal order (i.e. leave Canada voluntarily or be deported).

It is urgent that Chris Alexander, Minister of Citizenship and Immigration, opposition critics, and your Member of Parliament know of your support for the war resisters, to prevent current and potentially future deportation orders. As Canada enters into conflict in Iraq, having once refused to enter the war, it is vital to let elected representatives know of your support for those who have always objected to the Iraq War (which has seeded the current situation) and who should be protected by Canada and not sent back to the US to face punishment that amounts to persecution. Please read our materials and act.

### Is it time for a Canadian military intervention in Iraq?

We are all concerned with the incredible violence and human suffering in Iraq and Syria. Most discussion today seems to centre around which forms of violent response will work best and how Canada should support these. But is a violent response the only, or even the most effective, option that the international community has left, given the extreme and chilling realities in Syria and Iraq?

## CFSC issues multiple open letters on Indigenous rights

Quaker Indigenous Rights program committee has been busily working with partners to:

- Draw attention to Canada's indefensible behaviour at the World Conference on Indigenous Peoples. A consensus outcome document was approved but, as Chief Perry Bellegarde put it, "Alone among all the UN members, Canada instead chose to use this forum to make another unprincipled attack" on the UN Declaration on the Rights of Indigenous Peoples: <u>http://quakerservice.ca/news/canada-uses-world-conference-continue-indefensible-attack-undeclaration-rights-indigenous-peoples/.</u>
- Call on British Columbia to use the Tsilhqot'in decision as a framework for a principled and respectful relationship between Indigenous and non-Indigenous peoples -<u>http://quakerservice.ca/news/open-letter-government-bc/;</u>
- Call the attention of the Convention on Biological Diversty to the fact that a decision it has drafted would attempt to change the meaning of "Indigenous Peoples" as "Peoples" and would therefore impose limitations that are regressive and in violation of the rule of law <u>http://quakerservice.ca/news/cbd-draft-flawed/;</u> and
- Recognize the 7th Anniversary of the adoption of the United Nations Declaration on the Rights of Indigenous Peoples - <u>http://quakerservice.ca/news/7th-anniversary-un-declaration-rights-</u> <u>indigenous-peoples/</u>.
