

Breaking news - Ontario approves anti-BDS motion

"It is deeply troubling when we see extremely important and powerful words like antisemitism being compromised through misuse to promote a political agenda... Simply put, the Government of Ontario has taken the path laid out for it by lobbyists seeking to silence legitimate nonviolent protest," reads a statement released today by CFSC.

Earlier today Members of Provincial Parliament debated a motion to "reject the differential treatment of Israel, including the Boycott, Divestment and Sanctions movement," without any acknowledgement in either the motion or the debate of why the BDS movement exists or what its actual aims or methods are.

"Have the politicians making these decisions spoken with the wide range of supporters of BDS, including Friends, who collectively support a boycott of the products of illegal Israeli settlements?

"We seek justice and peace for all. We acknowledge that we have much to learn and that our perspectives are never complete. We hope to learn in conversation with Israelis and Palestinians, and Jewish and Palestinian Canadians. We hope to learn in a Canada that respects its citizens' rights and refrains from cynically attacking the very values underlying a peaceful society, while

claiming to be attacking hatred. We seek a world where hatred, whether in the form of antisemitism in Toronto or the unconscionable blockade of Gaza by Israel, is overcome through nonviolence."

At CFSC we recognize that the children of incarcerated parents are deeply affected by the separation brought on by incarceration. This separation often impacts the financial stability of the family which is most evident during the holiday season. We recently became aware of the Angel Tree Christmas Program and we'd like to invite Friends and meetings across Canada to volunteer some time this holiday season.

Angel Tree supports the children of incarcerated parents by purchasing, wrapping, and delivering a Christmas present to the child of a parent who is currently incarcerated, on behalf of that parent. This supports the child in knowing that they are cared for and remembered during the holiday season.

Canada renews support of Palestinian refugees

You may recall that last month Canadian Yearly Meeting joined with other churches in calling for restored funding to the United Nation's agency UNRWA. UNRWA provides education, medical care, and other essential services to Palestinian refugees. We are pleased to see that Canada has now committed to funding UNRWA at \$25 million per year. Churches have written to thank the government for this renewed funding, noting,

"It is encouraging that the Government of Canada has pledged CDN \$25 million annually to support education and healthcare for vulnerable Palestinian children, women and men. By adopting these measures Canada is demonstrating strong leadership in responding to the needs of one of the most vulnerable communities in the world. Thank you for the quick and generous response on this issue....

For this to be truly effective in the long-term, efforts to secure a just and lasting peace in the region are urgently needed. We urge the Government of Canada to support initiatives that result in peace with justice between Israel and Palestine."

Reflections on Muskrat Falls

The Lower Churchill Hydroelectric Project at Muskrat Falls has been contentious since construction began in 2013. Recent studies by Harvard University scientists have shown that if the dam reservoir is not fully cleared of vegetation before flooding begins, there will be a significant increase in toxic methylmercury in the watershed.
