# Big news about UN Declaration Bill

Readers of the E-News will be familiar by now with the *UN Declaration on the Rights of Indigenous Peoples*. We've worked with partners for many years to raise its profile as the human rights instrument essential to promoting just relationships between Indigenous Peoples and non-Indigenous Peoples.

For the past two years we've worked continuously with partners to call for Canada to do more than just say it supports the *Declaration*. We've called for a legislative framework to ensure full and effective implementation. Making Canada's laws consistent with the *Declaration* is a major and important step in the ongoing process of reconciliation. The federal government has been hesitant to commit to a legislation framework.

Last week, at a symposium we helped organize, Justice Minister Jody Wilson-Raybould surprised everyone by announcing that the government of Canada had *changed its position*. It will endorse private members Bill C-262 and support the full implementation of the *UN Declaration on the Rights of Indigenous Peoples*!

This is a huge win and a testament to the power of quietly convening people to discuss important issues. We've been there along the way, helping key groups work through their conflicting viewpoints and needs. Sometimes this quiet diplomacy can help major change take shape, change that once seemed impossible.

If you feel led, you may wish to contact your member of parliament to express your pleasure with Minister Jody Wilson-Raybould's announcement, and that you hope your MP will be supporting Bill C-262.

# Joint letter supports disease treatment centre

In an open letter to Prime Minister Justin Trudeau and Ontario Premier Kathleen Wynne, prominent human rights and environmental organizations urged the federal and provincial governments to ensure people from the Grassy Narrows First Nation have access to specialized, long term medical care for mercury poisoning. Seven groups, including CFSC, have written in support of the Grassy Narrows First Nation appeal for the creation of a specialized facility in their community to meet the needs of those suffering from the effects of mercury poisoning resulting from contamination of their river system.

"The basic human rights of the people of Grassy Narrows have been denied for decades. A medical treatment centre is a step to recognize and respond to the terrible injustices imposed and ignored by industry and governments. We stand with the people of Asubpeeschoseewagong to insist that they have access within their community to the specialized health care they need," said CFSC Clerk Derek Nice.
