



It's time to pass Bill C-262

CFSC program assistant Keira Mann recently escorted a delegation of national leaders from the Anglican Church, the United Church, the Presbyterian Church, and Mennonite Central Committee around the Canadian Senate. The purpose of these visits was to urge Senators to pass Bill C-262, *An Act to ensure that the laws of Canada are in harmony with the UN*

Declaration on the Rights of Indigenous Peoples.

The delegation met with four Senators and the staff of one more to discuss the Bill and what their congregations have been doing toward reconciliation and furthering Indigenous Peoples' human rights in Canada. The group encouraged each Senator to support the Bill within the Senate and among their colleagues. They were also introduced in the Senate Gallery by Senator Nancy Hartling, a supporter of Bill C-262.

Joint letter asks Canada to distinguish between Israel and illegal settlements

Bill C-85 seeks to update the Canada-Israel Free Trade Agreement (CIFTA). The Agreement includes some commendable features, including chapters on gender, corporate responsibility, labour and environmental protections. CIFTA has some glaring ommission as well.

In its trade agreement with Israel, the European Union makes it clear that the benefits of the agreement do not extend to Israel's settlements in illegally occupied Palestinian territory. CIFTA makes no such distinction. CIFTA is also silent about human rights and any

requirement to uphold them.

A new letter to Senators requests changes to bring CIFTA in line with Canada's legal and moral obligations. The letter was signed by UN Special Rapporteur Michael Lynk, Independent Jewish Voices, The United Church, Amnesty International Canada, Mennonite Central Committee, and Canadian Friends Service Committee. https://quakerservice.ca/wp-content/uploads/2019/03/Joint-Letter-Bill-C-85-CIFTA.pdf
