The prison system is both a cause and a result of violence and social injustice. Throughout history, the majority of prisoners have been the powerless and the oppressed. We are increasingly clear that the **imprisonment of human beings**, like their enslavement, is inherently immoral and is **as destructive to the cagers as the caged.**

Healing lodges Community-based treatment Therapeutic communities Restorative justice The challenge before us is to use alternatives based on economic and social justice and on the fulfillment of human needs. **Some alternatives to prisons have already been developed and more are needed** to bring about reconciliation and healing within the community. Friends need to seek out, develop and support such programs.

At the same time, we need to foster awareness in ourselves and others of the roots of crime and violence in society to ensure that our lives do not unintentionally reinforce these evils.

Prison abolition is both a process and a longterm goal. In the interim, there is a great need for Friends to reach out to and to **support all those affected: guards, prisoners, victims and families.**

We recognize a need for restraint of those few who are exhibiting dangerous behaviour. The kind of restraint used and the help offered during this time must reflect our concern for that of God in every person.
